All interested bidders are notified on the following clarifications on the particulars of the above tender.

The University of Nairobi intends to shortlist firms for Architectural Design Competition for the Science and engineering complex.

The University seeks to engage the services of a qualified consortium of firms/firm to provide the services for architectural design of the proposed Science and engineering complex through an **Architectural Design competition**.

To realize the above objective, The University seeks to:

- Undertake the construction of the Science and engineering complex in full consistency with the respective Terms of References (TORs). Any request for clarifications must be made in writing at least seven (7) days to the EOI closing date. All Clarifications and addendums will be posted on the University and Public Procurement Information Portal websites.
- 2. Eligible consulting firms are now invited ("Consultants") to indicate their interest in providing the above services. Interested consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the services. The shortlisting criteria on required qualifications and experience of the consortium firm/firm are detailed in the EOI Document under the Evaluation Criteria.
- 3. We draw attention to all interested Consultants to the following provisions that;
 - a. The Consultants will be expected to have no conflict of interest with other assignments or its own corporate interests and act without any consideration for future work.
 - b. The architectural programist already engaged with the university will not be eligible to participate in this competition.
 - c. On the selection for the RFP, the number of firms to be selected for the Request for Proposal (RFP) stage will be a minimum of five (5) and a maximum of seven (7).
 - d. The evaluation results shall be ranked from the highest to the lowest and submitted to the AFD for approval. The top Five (5) to seven (7) firms who score 70% and above in the detailed evaluation will proceed to the next stage of Request for Architectural Competition Proposal.
 - e. The consultant has no personal or business relationship with the Procuring Entity's senior management.
 - f. A firm or an individual in the firm has not been sanctioned by the Public Procurement Regulatory Authority or is under a suspension or debarment imposed by any other entity in Government of Kenya or any international organization.
- g. Government-owned enterprises or institutions of the Government of Kenya, officials and civil servants and employees of public institutions shall not be eligible to participate.
- 4. Consultants may associate with other firms to enhance their qualifications but should indicate clearly their nature of association. In any case of association, all partners shall be jointly and severally liable for the entire contract if selected.
- 5. A Consultant will be selected in accordance with the **Regulations** set out in the Public Procurement and Asset Disposal Act, 2015 and Regulations 2020.
